## TRAFFIC MANAGEMENT ORDER

WCC 2013 No. 8

The City of Westminster (Parking Places) (B Zone) (Amendment No. 4) Order 2013

Made: 18th February 2013

Coming into force on: 25th February 2013

The Council of the City of Westminster, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a) as amended, and of all other powers thereunto enabling, hereby make the following Order:

- 1. This Order may be cited as The City of Westminster (Parking Places) (B Zone) (Amendment No. 4) Order 2013 and shall come into force on 25<sup>th</sup> February 2013.
- 2. In this Order:

"enactment" means any enactment, whether public general or local, and includes any order byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment; and

"the Order of 2012" means The City of Westminster (Parking Places) (B Zone) (Consolidation No. 1) Order 2012(b).

3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2012 shall have effect as though for the parking places numbered 588 and 643 in Schedule 1 to that Order there were substituted the parking places similarly numbered and set out in columns 1 to 7 of the Schedule to this Order.

- (a) re-locates a shared use parking place 5 metres northwards on the south-eastern side of Lancaster Gate, outside 'The Lancasters'; and
- (b) reduces the length of a residents' parking place on the west side of Leinster Terrace, adjacent to No. 100 Bayswater Road;
